7. STORAGE AND HANDLING

STORAGE: Observe the label precautions. Store between 5°C and 25°C in a dry, well ventilated place away from sources of heat, ignition and direct sunlight.
No Smoking. Prevent unauthorised access. Containers which are opened should be properly resealed and kept upright to prevent leakage. Store separately from oxidising agents and strongly alkaline and strongly acidic materials.

HANDLING AND USAGE: Keep the container tightly closed. Exclude sources of heat, sparks and open flame. Avoid skin and eye contact. Avoid inhalation of vapour and spray mist.
Smoking, eating and drinking should be prohibited in storage and use areas.
For Occupational Exposure Control Measures, see Section 8.
Never use pressure to empty; the container is not a pressure vessel.
Always keep in containers made of the same material as the supply container.
The Manual Handling Operations Regulations may apply to the handling of containers of this product.
Refer to the guide weight indicated on the container when carrying out assessments.

8. EXPOSURE CONTROLS / PERSONAL PROTECTION (NORMAL USE)

EXPOSURE CONTROLS: Provide adequate ventilation. Where reasonably practicable this should be achieved by the use of local exhaust ventilation and good general extraction. If these are not sufficient to maintain concentrations of particulates and/or solvent vapours below the relevant Occupational Exposure Limit Values, suitable respiratory protection must be worn (See Occupational Exposure Controls below).

OCCUPATIONAL EXPOSURE CONTROLS: All personal protective equipment, including respiratory protective equipment, used to control exposure to hazardous substances must be selected to meet the requirements of the COSHH Regulations.

RESPIRATORY PROTECTION: Local exhaust ventilation and good general extraction should be used to control any build up of airborne material.

HAND PROTECTION: When skin exposure may occur, advice should be sought from glove suppliers on appropriate types and usage times for this product. The instructions and information provided by the glove supplier on use, storage, maintenance and replacement must be followed. 9. PHYSICAL / CHEMICAL PROPERTIES

10. STABILITY AND REACTIVITY

11. TOXICOLOGICAL INFORMATION
